Finance & Funding

SNTC is jointly supported by the Ministry of Social and Family Development (MSF) and National Council of Social Service (NCSS). The Company will charge its clients a flat one-time set-up fee and annual administrative fees for providing the trust services.

Reserves

SNTC's Reserve policy is to maintain a reserve of 3 years' operating expenses. The reserves will be placed in Fixed Deposits and cash in bank.

Since the launch on 29 October 2009, SNTC has reached out to 3,781 parents/caregivers/ social workers/doctors/nurses/financial planners to raise awareness of the trust scheme. 433 caregivers consulted SNTC case mangers to develop care plans for their loved ones with special needs. 165 of these parents/caregivers have set up trust accounts with SNTC.

REVIEW OF FINANCIAL STATUS

The major expenses incurred are for operations and publicity programmes.

FUTURE PLANS AND COMMITMENTS

SNTC plans to extend its trust scheme to serve the aging population. This proposed trust will also encourage potential settlors to draw up a Lasting Power of Attorney to appoint donees to manage their affairs in the event that they lose mental capacity. The appointed donees will then work with SNTC to manage their personal and financial affairs of the settlors when they no longer have mental capacity.

Manpower

SNTC will increase it's current staff support to meet the increasing demand for its trust services. In the new financial year, SNTC will have the following staff support:

Donations

SNTC has registered with SG Gives and Simply Giving to receive online donation. Donations are set aside to assist low income families with the minimum sum required to set up a trust account for their dependants with special needs.

Office Expansion

On 1st January 2013, SNTC moved into new premise, within the same Social Service Hub, with bigger office space of 1,108 sq ft to accommodate additional headcounts and office equipment.
